Upcoming Activities

Demolition

Contractors for the Frederick Douglass Tunnel Program are scheduled to begin demolition of 2235 Edmondson Ave (former Poco Pico building) on or about March 17. The on-site work will begin with the installation of a steel project fence with screening. This safety measure is intended to keep adjacent property owners safe from construction activity.

New Construction

This week, crews will begin constructing a temporary noise wall along N Pulaski St between Harlem and Raynor Avenues in advance of future utility work in the area. This wall will take approximately 2 weeks to complete. Once in place, the wall will reduce noise from the construction area to adjacent properties.

Amtrak is committed to conducting this work in a manner that is least disruptive to the community. For your safety, we ask that you please keep all children and pets away from the construction area.

During construction, you can expect:

- Workers and construction vehicles in and around the construction site
- Increased noise levels, consistent with typical construction activity
- Intermittent closure of sidewalks and walkways
- Temporary parking restrictions, when needed

Ongoing Activities

Demolition

- Contractors for the Frederick Douglass Tunnel Program are scheduled to begin demolition starting March 10th at 2335 W Franklin St. The on-site work began with the installation of a steel project fence with screening. This safety measure is intended to keep adjacent property owners safe from construction activity.
- Crews continue to conduct surveys, complete preconstruction inspections, install instrumentation and monitoring devices, and complete utility investigations throughout the Program area.
- Crews continue to work in the 700 block of N Pulaski Street. In preparation for some additional utility work, a **full road closure of N Pulaski Street between Lafayette Avenue and Harlem Avenue** will be implemented on or about March 10, 2025. During this time residents can expect:
 - Installation of fencing around the work area
 - Message boards and no parking signs
- Crews continue to install temporary water lines along N Payson, N Pulaski, N Brice and W Lanvale Streets. Expect possible lane closures and intermittent sidewalk closures in the area.
- As a part of the water line relocation in the N Payson area, crews will perform meter connection tie-ins which will **require a planned water outage during the week of March 10th for approximately two hours. Impacted homes will receive prior notification.**

At this time, no additional areas are expected to have interruptions to water. If this should change, we will contact customers.

PLEASE NOTE:

Crews generally work Monday through Friday from 7:00am to 5:00pm, weather permitting. Construction activities are subject to change and modifications to the schedule may become necessary due to weather delays or other unforeseen conditions. Please use caution when traveling in construction areas.
