Private Car Inspector Qualification Protocol Effective January 1, 2019

A. DEFINITIONS

- 1. Amtrak: The National Railroad Passenger Corporation, a corporation organized under 49 U.S.C. § 24101 *et seq.*, and the laws of the District of Columbia with offices at 1 Massachusetts Avenue, N.E., Washington, D.C. 20001.
- 2. Amtrak Private Car Website: The portion of the amtrak.com website that is devoted to Private Cars. The URL is: https://www.amtrak.com/planning-booking/private-train-cars.html.
- 3. Amtrak Property: Land, yard, tracks, or other real or personal property owned or controlled by Amtrak.
- 4. Amtrak Train: A train operated by Amtrak for its own account, i.e., not operated by Amtrak under contract to another entity.
- 5. Indemnitees: Amtrak, its directors, officers, employees, contractors, agents, and servants, its host railroads, other railroads or transit agencies to the extent Amtrak is obligated to indemnify or save harmless such railroads and transit agencies, station and terminal companies, other railroads on whose right of way or property the Private Car operates, and their respective directors, officers, employees, contractors, agents and servants.

- 7. Private Car: A railroad passenger car owned, leased, operated, or otherwise controlled by a Private Car Owner and has had an 800000-series number assigned by Amtrak.
- 8. Private Car Inspector: A private contractor who meets the requirements set forth in this Private Car Inspector Qualification Protocol and is placed by Amtrak on the Private Car Inspectors List.
- 9. Private Car Inspectors List: A list maintained by Amtrak of Private Car Inspectors and available on the Amtrak Private Car Website.
- 10. Private Car Maintenance Contractor: A private contractor or subcontractor hired by a Private Car Inspector or Private Car Owner to perform maintenance services under his or her authority, responsibility, and direction.
- 11. Private Car Owner: A party other than Amtrak who owns, leases, operates, or otherwise controls a Private Car, including the Private Car Owner's employees, contractors, subcontractors, lessees, agents, and servants.

B. ROLES

Private Car Inspectors certify that Private Cars are in suitable mechanical condition for safe operation on Amtrak Trains. Private Car Inspectors are selected from the Private Car Inspectors List, hired, scheduled, and paid directly by Private Car Owners. Private Car Inspectors establish payment arrangements directly with Private Car Owners. No billing, payment, or any other matter regarding Private Car Inspectors and their relationship with Private Car Owners are handled by or through Amtrak.

C. INSPECTION AND QUALIFICATION REQUIREMENTS PROCESS

- 1. Commencing January 1, 2019, to be eligible for placement on the Private Car Inspectors List, all of the requirements in this document must be met by prospective Private Car Inspectors. The previously qualified Private Car Inspectors must re-qualify by successful completion of all requirements in this document no later than six months after approval by the Federal Railroad Administration of the training class outlined in Section 1.c, during which six-month period Amtrak will offer the class. During the interim period until such class has been approved and offered, the previously qualified Private Car Inspectors must (1) maintain their QMP Qualification as outlined in Section 1.d, and (2) by July 1, 2019, must provide evidence of insurance as outlined in Section 1.e and execute an agreement to the terms of this document, other than Sections 1.a and 1.c, as outlined in Section 2.
 - a. As a prerequisite for enrolling in the Amtrak Private Car Training Class (see step (c)), potential inspectors must demonstrate experience, knowledge and understanding of how to properly maintain and repair railway passenger cars, including safety critical systems such as trucks, air brakes, and safety appliances. This requirement may satisfied by providing Amtrak training and work records for persons who are current/former Amtrak employees, and by submission of a resume and references for others. In the latter case, at least one reference should be a currently approved Amtrak Private Car Inspector. Parties who desire to enroll in the class may contact Amtrak's Manager of Special Movements.
 - b. Provide an affidavit attesting that he or she has a clean record with no legal or administrative fines, penalties, or judgements, including but not limited to Federal Railroad Administration actions entered against him or her related to private car inspection or maintenance work for the preceding five (5) years.
 - c. Successfully complete an Amtrak Private Car Training class. This is a prerequisite for enrolling in the Amtrak QMP Certification class (see next step). All Private Car Inspectors must successfully complete this class once before inspecting Private Cars. This class is offered periodically by Amtrak's Training Department. Parties who desire to enroll in the class may contact Amtrak's Manager of Special Movements. This certification must be renewed every six years to remain on the Private Car Inspectors List.
 - d. Successfully complete an Amtrak QMP Certification class to obtain a Qualified Maintenance Person ("QMP") certification. Classes are offered by Amtrak's Training Department. Parties who desire to enroll in a class may contact Amtrak's Manager of Special Movements. These certifications must be renewed every three years; the certifications that Private Car Inspectors are required to keep current to remain on the Private Car Inspectors List are as follows:
 - Train Brake Test
 - Locomotive Departure Test
 - Passenger Car Daily
 - Passenger Car PM
 - Single Car Test; Passenger
 - Single Car Test; Freight

- e. Provide to Amtrak a Certificate of Insurance giving evidence that the Commercial General Liability insurance required by Attachment A of the Temporary Permit to Enter for Private Car Inspectors (available on the Amtrak Private Car Website) is in place whether the Private Car Inspector enters Amtrak Property or not. If entering Amtrak Property, the Private Car Inspector must satisfy all additional provisions of Amtrak's then-current Temporary Permit to Enter for Private Car Inspectors.
- 2. A prospective Private Car Inspector must submit written evidence of fulfilling the requirements of Section 1 and agreement to the terms of this document to Amtrak's Manager of Special Movements in a format specified by Amtrak's Manager of Special Movements. If the evidence meets the conditions of Section 1, the Inspector's name and contact information will be eligible for placement on the Private Car Inspectors List. The decision of whether or not to place a Private Car Inspector's name and contact information on the Private Car Inspectors List shall be at Amtrak's sole discretion and shall be final. The Private Car Inspectors List, as may be amended from time to time, shall be available on Amtrak's Private Car Website and shall be the definitive list of Private Car Inspectors qualified to inspect Private Cars.
- 3. Any Private Car Inspector on the Private Car Inspectors List will be subject to the following:
 - a. By appearing on the Private Car Inspectors List, the Private Car Inspector agrees that Amtrak assumes no responsibility for and makes no representations or warranties, express or implied, as to the qualifications of, or work or inspections performed by, Private Car Inspectors and/or Private Car Maintenance Contractors, and that the Private Car Inspector will release Indemnitees from any liability related to being placed on or removed from the Private Car Inspectors List, and defend, indemnify and hold harmless Indemnitees from any liability arising from the Private Car Inspector's work or this Protocol. The foregoing obligation shall not be limited by the existence of any insurance policy or by any limitation on the amount or type of damages, compensation, or benefits payable by or for the Private Car Inspector or any contractor or subcontractor and shall survive the termination or expiration of being listed on the Private Car Inspectors List for any reason.
 - b. Amtrak reserves the right to suspend or remove a Private Car Inspector from the Private Car Inspectors List at any time, for any reason, such reason to be communicated by Amtrak to the Private Car Inspector in a Notice of Termination. Such reasons may include, but are not limited to, Sections 3(c) through 3(k) below.
 - c. Amtrak may conduct random, unannounced audits of any Private Car Inspector's work at any time, for any reason, without the Private Car Inspector present. Failure to pass any Amtrak audit, as determined in the sole discretion of Amtrak, will result in immediate removal of the Private Car Inspector from the Private Car Inspectors List. Audit results will be transmitted in writing to the Private Car Inspector under audit who may offer comments or explanation to Amtrak's Manager of Special Movements within 60 days of the effective date of the removal. Following submission of the explanation, or in cases where no explanation is offered; the Private Car Inspector shall remain removed unless Amtrak's review of the explanation, if any was provided, causes Amtrak to terminate or modify the removal. The decision to remove a Private Car Inspector from the Private Car Inspectors List shall be at Amtrak's sole discretion and shall be final.
 - d. Any fine, penalty, judgement, etc. as described in Section 1(b) lawfully adjudicated against a Private Car Inspector, or failure of a Private Car Inspector to report any such fine, penalty,

- judgement, etc. to Amtrak's Manager of Special Movements, will result in the immediate removal of the Private Car Inspector from the Private Car Inspectors List.
- e. The Private Car Inspector shall be fully cognizant of and governed by all appropriate safety rules and standards governing their conduct in and about railroad property and equipment, which at a minimum includes safety rules and standards issued (1) by Amtrak and available on Amtrak's Private Car Website, (2) by each host railroad on which the Private Car is located, and (3) by any applicable agencies having jurisdiction over the Private Car and the Private Car Move such as the Federal Railroad Administration (see applicable parts of 49 CFR Parts 200-299). It is the responsibility of each Private Car Inspector to be familiar with and comply with all applicable rules and standards.
- f. The instructions of Amtrak personnel are to be adhered to at all times.
- g. The Private Car Inspector shall not offer or cause to be offered to any Amtrak employee any Business Courtesies. A Business Courtesy is a present, gift, hospitality or favor for which fair market value is not paid by the recipient. A Business Courtesy includes tangible or intangible benefits such as meals, drinks, entertainment, door prizes, transportation, discounts or professional items. Prohibited gifts include but are not limited to cash; services or gifts greater than \$10.00 (ten dollars) in value; transportation; favors; bonuses; commissions or kickbacks; living expenses; or entertainment.
- h. Amtrak does not allow the same Private Car Inspector to perform more than two consecutive annual inspections on the same Private Car.
- i. A Private Car Inspector may not provide any inspection or approval on work he or she has performed on a Private Car.
- j. Inspections and associated repairs by a Private Car Inspector or Private Car Maintenance Contractor are authorized on Amtrak Property only for equipment that is covered by a valid Monthly, Short Term, or Long-Term Private Car Parking Permit at locations eligible for Private Car Moves and the Private Car Inspector holds a valid Temporary Permit to Enter for Private Car Inspectors, or for required Daily inspections not performed by Amtrak personnel during a Private Car Move. Amtrak Supervisors will provide blue flag protections and make available pit inspections, jacking pad and overhead fall protection areas as necessary, dependent on the availability of Amtrak facilities, equipment, and resources. This work shall not impede the servicing or maintenance of Amtrak equipment.
- k. To Remain on the Private Car Inspectors List, prior to expiration of a Private Car Inspector's QMP qualifications under Section 1(d), the Private Car Inspector must provide written evidence to Amtrak's Manager of Special Movements in a form specified by Amtrak's Manager of Special Movements that the Private Car Inspector's qualifications have been renewed and the new expiration date.
- I. A Private Car Inspector may at any time request to be removed from the Private Car Inspectors List by providing a request in writing to Amtrak's Manager of Special Movements.
- 4. If a Private Car Inspector is removed from the Private Car Inspectors List, the Private Car Inspector may seek to return to the Private Car Inspectors List by starting as a new prospective Private Car Inspector using the process in Sections 1 and 2, which application may or may not be accepted by Amtrak for processing at Amtrak's sole discretion.
- 5. If a Private Car Inspector is removed from the Private Car Inspectors List, all charges owed to Amtrak by the Private Car Inspector at the time of such removal will remain due and owing, and will not be eliminated.
